Organizations that intend to voluntarily reallocate some or all of their renewal project funding are strongly encouraged to contact their CoC Co-Coordinators as soon as possible.

June 29, 2026	NE CoC Board votes to approve final Scoring & Ranking Tool, Ranking & Reallocation Policies, and Ranking Procedure. Final drafts posted to the CoC website within 5 business days of Board approval.

June 16 – July 23, 2026	Rolling Intent to Apply Period for New Projects	New project Intent to Apply forms will be accepted on a rolling basis through July 23. Applicants will be notified of threshold status within 5 business days of submission. All applicants interested in applying for new projects must submit their intent to apply form by 11:59pm on July 23, 2026 to be considered for funding in the 2026 CoC Program Competition. New project applicants must still meet the CoC established project application deadlines to be considered for funding. The NE CoC may issue another call for new projects if there is additional funding available through CoC Bonus, DV Bonus, or Reallocated Funds.
July 6, 2026	Intent to Apply Deadline for Renewal Projects	All applicants interested in applying for renewal projects must submit their intent to

		apply form by 11:59pm to be considered for funding in the 2026 CoC Program Competition.
July 10, 2026	Renewal project applicants notified in writing if their project meets minimum threshold requirements and invited to apply for full application process.	Applicants will be notified of their eligibility to submit a full application within 5 business days of submitting their Intent to Apply form to the CoC.
July 22, 2026	E-SNAPS opens (https://www.hudexchange.info/programs/e-snaps/)	Applicants must complete a full project application in E-SNAPS. The CoC will notify applicants when HUD makes the applications available in E-SNAPS.
July 23, 2026	LOCAL PROJECT APPLICATION DEADLINE: Applicants must submit all local project application documents to the CoC either via the online application form or via email to Cara Oakland (clundquist@live.com).	Renewal and new projects must submit their local application and all required attachments by 11:59pm on Thursday, July 23, 2026 to be considered for funding in the 2026 CoC Program Competition.
Week of July 27, 2026	Ranking and Review Committee meets to review, score and rank any new project applications and to finalize the draft project ranking.	
August 5, 2026	PROJECT APPLICATION DEADLINE: Applicants must submit a completed ESNAPS project application by 11:59pm and email a PDF copy to Cara Oakland (clundquist@live.com).	
August 7, 2026	Project Applicants notified in writing by the Ranking & Review Committee if their project was reduced or rejected and if their project was accepted and ranked on the Priority Listing. New and Renewal Applicants notified in writing by the Ranking & Review Committee of proposed project rank on the Priority Listing.	
August 7, 2026	Draft Project Priority Listing posted to CoC website for public review and comment	
August 7, 2026	Draft Collaborative Application posted to CoC website for public review and comment.	

August 11, 2026	Deadline for applicants to appeal project scores.	Applicants may submit an appeal letter to the CoC via email (clundquist@live.com) by 11:59pm on August 11, 2026.
August 13, 2026	NE CoC Governing Board Meeting to review recommended Project Scoring & Ranking and Draft Collaborative Application	
August 18, 2026	Deadline for final corrections to Project Applications in ESNAPS.	Applicants must make all required changes to their E-SNAPS applications as outlined in their Project Notice of Score & Rank and submit the final application in ESNAPS by the deadline. Applications that are not submitted on time will not be included in the CoC Priority Listing.
August 18, 2026	Final Collaborative Application and Project Listing posted on CoC website for public review. CoC notified via email of availability.	
August 21, 2026	Final Collaborative Application and Project Listing submitted in E-snaps.	
August 26, 2026	HUD DEADLINE for Consolidated Application with project priority list, project applications, and all attachments.
